LEGAL OVERVIEW OF THE REGISTRATION CERTIFICATE (STR) FOR HEALTH OFFICER

Abstract : The legality of Registration Certificates (STR) for Health Workers in carrying out their duties at AM Parikesit Hospital Tenggarong is an administrative requirement that must be owned by health workers before the Covid-19 pandemic even a valid STR is an administrative requirement that must be attached when registering as a candidate for health workers in hospitals AM. Parikesit, but with the Covid-19 pandemic until now, these provisions have been relaxed and even allowed for health workers to practice without having an STR as in Circular Letter Number HK.02.01/MENKES/4394/2020 concerning Registration and Licensing of Health Workers during a Pandemic Corona virus Disease 2019 (Covid-19), there is tolerance and exceptions related to STR ownership. Therefore, the existence of these regulations provides legal certainty (legality) for RSUD AM. Parikesit currently employs health workers to serve the public who need services both related to Covid -19 and those who are not, so that the presence of health workers whose registration certificates are still in the process of being extended or who have just submitted them is legally considered legal. have a registration certificate and/or practice license. Therefore all actions of health workers in carrying out their service duties in a competent manner have authority and there is no violation of the law. The legal consequences for health workers in carrying out their duties at AM Parikesit Hospital who do not have a Registration Certificate (STR) and those who have a Registration Certificate (STR) but are not in accordance with the field of health education must be distinguished in two circumstances, namely normal conditions and emergency situations.

I. INTRODUCTION

Health is a human right and one of the elements of welfare that must be realized in accordance with the ideals of the Indonesian nation as stipulated in the 1945 Constitution. Article 28 H paragraph (1) of the 1945 Constitution of the Republic of Indonesia mandates that everyone has the right to obtain health services. This is in line with Article 34 paragraph (3) which states that the state is responsible for providing proper health service facilities and public service facilities.

Every activity in an effort to maintain and improve the highest degree of public health is carried out on a non-discriminatory, participatory and sustainable basis in the formation of Indonesian human resources, as well as increasing the nation's resilience and competitiveness for social development. Every development effort must be based on health insights in the sense that national development must pay attention to public health and is the responsibility of all parties, both the government and the community.

Health workers have an important role to play in improving the maximum quality of health services for the community to realize human rights in the health sector, therefore health services must be able to increase awareness, willingness and ability to live healthily so that the highest degree of health will be realized. as an investment for the development of productive human resources social and economic as well as one of the elements of general welfare as referred to in the preamble of the 1945 Constitution.

A graduate from a school or college in the health sector does not immediately become a health worker or someone who can carry out tasks in the health sector, because after graduating a health worker must meet administrative requirements before carrying out tasks according to their profession. As stated in Article 44 paragraph (1) of Law Number 36 of 2014 concerning Health Workers that : "Every health worker who practices is required to have an STR".

The definition of STR refers to the provisions of Article 1 paragraph (10) of Law Number 36 of 2014 concerning Health Workers, it states that: "Registration Certificate, hereinafter abbreviated as STR, is written evidence given by the council of each health worker to a health worker who has registered".

II. RESEARCH METHODS

Type his research use Empirical law research method, which research examines drafted law as "actual behaviors" ie behavior real as symptom social nature experienced writing in connection society and environment surrounding. (Abdulkadir Muhammad, 2004:55). Place and time study choose location study namely at home Sick Regional General Aji Muhammad Parikesit Tenggarong.

III. RESULT AND DISCUSSION

Legality of Registration Certificate (STR) for Health Workers in carry out his job

Registration Certificate is confession in a manner juridical that somebody own authority on something field, so the Registration Certificate own function as confession legally for power health in practice. Registration Certificate (STR) for power health is condition mandatory administration owned in carry out his job in accordance with duties and powers. Registration Certificate (STR) for power health can likened like a license Driving (SIM) for a driver vehicle motorized, no have a Registration Certificate (STR). power health No can carry out job. Arrangement regarding the Registration Certificate (STR) for power health has arranged in various provision like in Constitution Number 36 of 2014 concerning Health Workers and Regulation of the Minister of Health of the Republic of Indonesia Number 83 of 2019 concerning Registration of Health Workers.

Article 44 paragraph (1) of the Law Number 36 of 2014 concerning Health Workers that: "Every health worker who runs practice must have STR'. With exists obligation the give threat penalty for power health does work and/or party institution health that employs him, as determined in Article 85 paragraph (1) of the Law Number 36 of 2014 concerning Health Workers, determines that: "Every health worker who on purpose operate practice without have STR as meant in Article 44 paragraph (1) is punished with a maximum fine of IDR 100,000,000 (one hundred million rupiah). Reny Tri Wahyuni, M.Adm.Kes, Position Head of General Section of AM Parikesit Hospital Tengrong next called as dr. Reny (September 15, 2022). To problem STR legality for power health in a manner norm he thought is obligatory obligations power owned health before and when will do practice work in accordance with background his education, because that guarantee exists order and not exists violation applicable regulations specifically for power health therefore in recruitment power health especially in AM Parikesit Hospital has determined condition general must fulfilled and done determined by the management of RSUD AM Parikesit For candidate applicant in the field power health for example condition necessary administration fulfilled for applicants, namely:

- 1. Make letter the intended application to Director of AM Parikesit Hospital.
- 2. Have an E-KTP or letter information Once record of the E-KTP issued by the Department of Population and Registration Civil in accordance domicile applicant.
- 3. Have Diploma and Transcript mark final in accordance educational formation and qualifications applied for.
- 4. body healthy and not own disease comorbidities / comorbidities.
- 5. Have a valid Registration Certificate (STR) apply up to a minimum of 1 (one) year.
- 6. A number of letter must statement signed above materials and terms support other specified in announcement reception power new health.

Besides set thing for a candidate power health at AM Parikesit Hospital , things that don't lost importance is monitoring and evaluation administration for employee specifically power health that has working at AM Parikesit Hospital, which has no other purpose from supervision That Alone evaluate power health in accordance with expertise and assurance that permission practice and Registration Certificate (STR) always still apply during operate task give service health at AM Parikesit Hospital. Because it, deep give legality of working Health Workers or give service health at AM Parikesit Hospital, accordingly applicable rules and regulations that is among other things, after power health accepted, besides given contract work, energy health will done credentials by the committee of each type power health in accordance with competence of the Registration Certificate (STR) they have For get Details Authority Clinical (RKK) determined by the leadership of AM Parikesit Hospital from results recommendations made by the committee. Besides That power health must administering permits Practice (SIP) at the Investment and Service Office Integrated One Door (DPMTSP) through recommendations from RSUD AM Parikesit and the District Health Office.

- a) Registration Certificate and/or Permit Practice power health that has expired but the process of extending the Registration Certificate and/ or Permit Practice constrained condition disaster national or emergency health the Corona Virus Disease 2019 (COVID-19) community, then a Registration Certificate and / or Permit Silverware stated Still still valid for a maximum of 1 (one) year since the disaster status national or emergency health community Corona Virus Disease 2019 (COVID-19) declared revoked by the Government.
- b) Health workers who have submit application for a Registration Certificate and/ or Permit Practice For first time however constrained condition disaster national or emergency health community Corona Virus Disease 2019 (COVID-19), declared has have a Registration Certificate and/ or Permit The practice is valid for a maximum of 1 (one) year since the disaster status national or emergency health community Corona Virus Disease 2019 (COVID-19) declared revoked by the Government.
